

LICENSE AGREEMENT

EAGLE CYBER SECURITY PLATFORM

This **License Agreement** ("Agreement") is entered into by and between **Futtuure Technology LLC** ("Provider") and the authorized user or entity accessing the **Eagle Cyber Security Platform** ("End User" or "You"). By accessing or using the platform, You acknowledge and agree to the terms of this Agreement. If You do not agree, You must not use the platform.

1. DEFINITIONS

1.1 Platform: The Eagle Cyber Security Platform, a Software-as-a-Service (SaaS) solution for cybersecurity monitoring, risk management, and threat analysis.

1.2 Provider: Futtuure Technology LLC, the owner and operator of the Platform.

1.3 End User: The individual or entity authorized to use the Platform under this Agreement.

1.4 Subscription Plan: The specific service tier or package selected by the End User, which defines access and features.

1.5 User Data: Data provided by or generated from the End User's use of the Platform.

2. LICENSE GRANT

2.1 License: The Provider grants You a non-exclusive, non-transferable, and revocable license to access and use the Platform in accordance with the terms of this Agreement and your Subscription Plan.

2.2 Restrictions: You may not:

- Share, transfer, or sublicense access to the Platform.
- Reverse engineer, decompile, or create derivative works of the Platform.
- Use the Platform in violation of applicable laws or to harm its integrity, security, or performance.

3. SUBSCRIPTION PLANS AND PAYMENT TERMS

3.1 Monthly Subscription: Payment must be made by the 10th day of each month. Invoices will be issued by the 3rd day of each month.

3.2 Annual Subscription: Payment is due upon renewal of the contract.

3.3 Late Payments: For monthly subscriptions, access will remain active for 15 days after the payment due date. If payment is not made within 30 days, access will be suspended. Late payments may incur a penalty fee of [X%] and interest of [Y%] per month.

4. OBLIGATIONS OF THE PROVIDER

4.1 Ensure the Platform's availability at least 99% of the time, excluding scheduled maintenance or force majeure events.

4.2 Protect User Data in compliance with applicable data protection laws.

4.3 Provide technical support and updates in line with the selected Subscription Plan.

5. OBLIGATIONS OF THE END USER

5.1 Use the Platform responsibly and in compliance with all applicable laws and this Agreement.

5.2 Protect access credentials and notify the Provider immediately of any unauthorized access or security breaches.

5.3 Avoid any actions that could compromise the Platform's security, performance, or availability.

6. CONFIDENTIALITY

6.1 Both parties agree to keep confidential all non-public information exchanged under this Agreement. This obligation shall survive for 3 years after the termination of this Agreement.

7. DATA USAGE AND PRIVACY

7.1 The Provider may collect and use anonymized data for improving the Platform's functionality and for analytical purposes.

7.2 User Data will be processed only as necessary to provide services and in compliance with applicable data protection laws, including GDPR or similar regulations.

8. LIMITATION OF LIABILITY

8.1 The Provider's liability is limited to the total subscription fees paid by the End User in the preceding 12 months.

8.2 The Provider is not responsible for indirect damages, loss of profits, or data loss resulting from misuse of the Platform.

9. TERM AND TERMINATION

9.1 This Agreement is effective upon subscription and remains valid until terminated by either party.

9.2 The Provider may terminate access if You breach the terms of this Agreement or fail to make payments within the specified timeline.

10. GOVERNING LAW

10.1 This Agreement is governed by the laws of the State of Delaware, United States of America. Any disputes arising under or related to this Agreement shall be resolved exclusively in the courts located in Wilmington, Delaware.

11. ENTIRE AGREEMENT

This Agreement constitutes the entire understanding between the parties regarding the use of the Platform and supersedes any prior agreements or understandings.
